PARENT AGREEMENT

- A well balanced lunch and snacks must be provided by the family. Toddlers will only be given food sent in by parents/care givers.
- All bedding, extra clothing, milk/juice, diapers, wipes, and ointments must be supplied by the family. All items must be labeled with the child's name.
- The annual registration fee of \$125 accompanies this application and reserves a spot for my child for September 2025. This covers insurance and administrative fees for the 2025-2026 school year. **The registration fee is non-refundable.**
- I agree to submit all forms, including an up-to-date physical and immunization records, and a copy of both parents (and guardians) driver's licenses (see transportation policy in Student Information form packet) by June 7, 2025. Students will not be permitted to attend without all paperwork, and physical and immunization records submitted and the first month's tuition paid.
- I understand that Little Pals Preschool is not open during Christmas and Easter breaks, as well as the other dates indicated on the annual calendar (calendar available in June 2024). Daycare may be available on some break days. See Holidays and Breaks below.

FINANCIAL INFORMATION & AGREEMENT

- I agree to pay September tuition by June 7, 2025. I understand that I will forfeit my child's placement at Little Pals if I do not pay the first month's tuition by June 7, 2025.
- •I understand my second tuition payment is due no later than September 1, 2025, and the first of each month thereafter. My last payment for the 2025-26 school year is due May 1, 2026 for 10 month commitment and August 1, 2026 for 12 month commitment.
- Tuition can be paid by check or cash. September 2025 tuition (tuition due by June 7, 2025) must be made by check, cash or money order.
- By agreeing to pay tuition by the first of each month, I understand that a late fee of \$25 will be charged if tuition is received after the 7th of the month.
- I also understand that the fee for *returned checks is* \$30.00. If a second check is returned, all future payments will be made by cash or money order.
- •I agree that any hourly before and aftercare fees (\$13.00 for any part of an hour) will be paid in full the week after they are incurred.
- I understand that the monthly tuition reflects the total program tuition divided over a payment period of ten months and therefore is not pro-rated due to holidays, illness, mandated closures, weather related closures, vacations or cancellations. I understand that there are no discounts, make ups, credits or refunds for these or any other unforeseen circumstances.
- Holidays and Breaks: I understand Little Pals Preschool and Daycare will be closed on major holidays. Little Pals is also closed for Christmas and Easter breaks, the last week of June and the last two weeks in August. Our annual calendar with exact dates will be available in June 2025.
 - a. Child care during holiday and breaks on published daycare dates is not included in regular full day (9am—3pm with or without daycare hours) tuition. However, child care may be available (at an additional cost) if there is sufficient interest. Sign-up & payment is required in advance.

NOTE: Parents paying full time extended tuition for 12 months will receive daycare during the last week in June and one of the two weeks in August at no additional cost. Those paying for full time extended for 10 months will receive daycare during the last week in June at no additional cost.

- **b. Full time extended commitment September 2025—June 2026**: Published daycare days during the last week in June are included in the full time extended tuition
- **c. Full time extended 12 month commitment July 2025—June 2026:** Published daycare days during one of the last two weeks in August 2025, and the last week in June 2026 are included in the full time extended tuition.
- I understand Little Pals closes at 6:00 pm. Late arrivers will be charged at the rate of \$15.00 per 15 minutes.
- •I understand that should I withdraw my child from Little Pals Preschool and Day Care that I must submit written notice one month in advance. Mid-month withdrawals will not be honored, and there will be no refund of tuition/ fees.
